The facility is scheduled for closure activities late summer of 2020. This Form 27 is being submitted to begin the closure process. All liquids and sediment will be removed, at which point the liners will be then removed. Soil samples will be collected from the pit sidewalls and pit bottom. Soil Samples will be submitted for laboratory analysis of constituents identified in COGCC Table 910-1.

We intend to collect eight soil samples from the pit. Because the pit is rectangular, two soil samples will be collected on the longer sides and one on each shorter end. Two soil samples will also be collected to characterize the bottom of the pit. Please see the attached diagram which depicts the proposed sample locations. All samples will be collected from the top 6 inches of soil immediately below the liners. Soil samples will be submitted for laboratory analysis of constituents identified in COGCC Table 910-1.
