An approved CPW seed and shrub mix will be hand broadcast on the earth disturbance. Erosion control blankets were installed on the fill slope disturbance for erosion control. The existing water bar and dirt berm on the fill slope will be maintained in place to provide sediment control. The dirt berm upgradient of the fill slope will also be maintained in place, used to direct run off away from the fill slope to provide additional erosion control. The noxious weeds were treated on 07/03/20.
