During this inspection the following possible compliance issues were observed: Tank missing required information. See photo #1485 with a corrective action date of 10/9/20. Tank label weathered and not legible. See photo #1486 with a corrective action date of 10/9/20. Trash on location. See photo #1487 with a corrective action date of 7/23/20. Multiple places with stained soils outside of containment. See photo #1488 and #1489 with a corrective action date of 7/23/20.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
