Previous inspection documented that the Location does not appear to be progressing towards final reclamation requirements and that noxious weeds were evident. Inspection required Operator to conduct additional work by 6/1/2020.

It was observed in this inspection that additional reclamation does not appear to have been conducted on the Location. Additionally noxious weed management does not appear to be occurring; What appears to be Field Bindweed and Musk thistle have established throughout the Location.
