It was observed in this inspection that Location is not progressing towards 1004 reclamation requirements; Vegetation observed on Location predominantly noxious weeds consisting of Field Bindweed or Houndstongue. Little to no desirable perennial vegetative establishment observed on Location.

Corrective Action:

Comply with 1004 rules. This inspection has 2 corrective actions and dates.

1) Conduct weed management pursuant to Rule 1004.e by 7/28/2020

2) Conduct additional reclamation to facilitate desirable vegetative establishment of the Location. The optimum seeding window for spring 2020 has passed. To allow Operator a more favorable seeding window outside of summer conditions, a CA date of 11/1/2020 is being provided.
