Distance from completed portion of the wellbore to nearest wellbore permitted or completed well in the same formation and within the unit was measured to the permitted Buford 33-3-3L measured in 3-D.

The distance from the proposed wellbore to nearest existing or proposed wellbore belonging to another operator, including plugged wells was measured to the plugged and abandoned Jordan 34-9 (API Number 05-123-12937). This measurement was taken from the Anti-Collision report and is measured to an unproductive portion of the Buford 33-2-2L wellbore.

Changes to this well are casing and cement program.

The oil and gas location has been built and has a producing well on it.

The 2A was amended in July of 2019 with updated Best Management Practices (BMP"s), per the director's objective criteria.

1	Drilling/Completion Operations	Logging: The Judy 3-4, API No. 05-123-50294, well drilled on the pad was logged with an open-hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run. The Judy 3-4, API No. 05-123-50294, is the well in which open-hole logs were run.
2	Drilling/Completion Operations	Anti-collision: Operator will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well.
