The seed mix was BLM approved via sundry on 2/8/2013. Vegetative coverage of the Desired Plant Community (DCP) based on the BLM approved seed mix (see below) has reached eighty percent (80%) and meets Onshore Order #1, 1997 White River Field Office Resource Management Plan Record of Decision completed reclamation standards and applicable APD COAs.

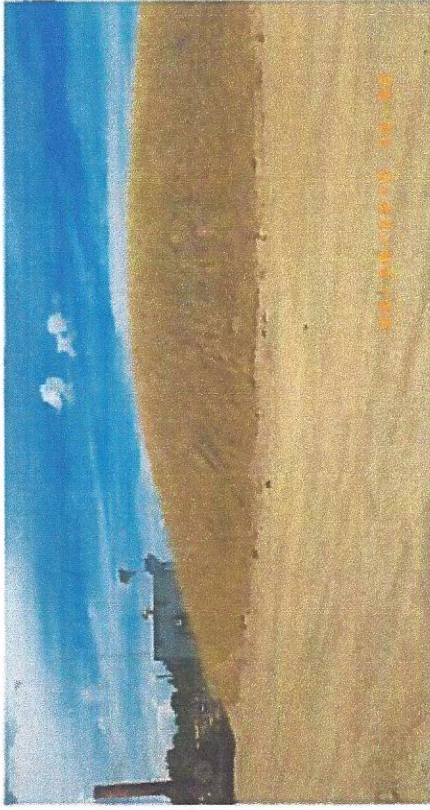
