The site is fenced and appears to be In Process of Final Reclamation. Vegetation is well established and progressing towards 80% revegetation. Cattle were grazing in project area and moved to Southeast corner to escape when disturbed by Inspector. Operator will also be notified by email to notify of need for fence repairs. A few Houndstongue rosettes as well as ruderal weeds were noted.

One valve can housing small diameter line and a black poly line remain on site; these are the unreclaimed facilities Failed above.
