<p>The well was plugged and abandoned on 3/19/2020. Per the 1003 Rules, all drilling pits need to be closed and reclaimed within 6 months after drilling and completion activities conclude for non-cropland. Therefore, the pits should be backfilled by 9/19/2020. All equipment appears to have been removed from the location. The soil piles are not maintained and protected from degradation of weeds and wind erosion. It is advised that recontouring and stabilization be performed by 9/19/2020. Soils piles will need to be stabilized and protected per 1002.c. Additional reclamation and seeding of the location should be performed during the fall season.</p>		Date

All disturbed areas must be recontoured, properly decompacted by cross ripping to a depth of 18 inches, have an adequate seedbed prepared, and then seeded with a seed mixture that reflects the surrounding vegetation. Erosion controls must be implemented that stabilizes the seeded soil. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels.
