These are not fresh water tanks, they are E&P waste tanks and close to Box Elder Creek (in a floodplain). Labels on tank are not freshwater labels. The tanks for the well (Gladys Cavanaugh) plugged next to this well by Extraction last fall had containments under them. Fresh water for cementing is brought in on separate trucks. Refer to Operator Guidance document, 603.h Floodplains. This well is PA and tanks are removed now.
