This inspection identified the following compliance issues:

1) Submit Form 22 in reference to the tank fire. Complete by 7-18-2020

Lighting occurred in the area at approximately 9 pm on 7-15-2020 which started at least 2 other minor wildland fires a few miles away. A fire at this tank battery was discovered the next day. The 2 tank lids had already landed 100' and 370' away. The hatches landed 100' and 130' away. At the start of this inspection, 11:45 AM, one tank fire was already out. The 2nd tank fire went out at approximately 5:00 pm on 7-16-2020.
