A form 42 notice was received indicating the well will be plugged and abandoned on 7/21/20.
Final reclamation will need to be performed upon plugging the well. Reseeding of the location and access road should be performed in the fall or prior to the next spring growing season.
The soils will need to be decompacted by cross ripping to a depth of 18 inches. Disturbed soils will need to be seeded and stabilized.
