Comment	<p><u>1) Based on an internal review, there was no oil and gas disturbance related to the patch of Scotch thistle; therefore, it is not the responsibility of the Operator- see Photo 10.</u></p> <p><u>2) The two native plant species of concern (Mentzelia nuda and Argemone polyanthemus) are not considered noxious and are not on the Colorado noxious weed list; therefore, the Operator does not have to perform control measures- see Photos 8-10.</u></p> <p><u>However, while COGCC staff performed an interim reclamation inspection, there were two List B Colorado noxious weeds, Scotch thistle and Musk thistle, observed along the access road and northeastern perimeter of location. Both of which were flowering at the time of this inspection- see Photos 1-3.</u></p>
