## INITIAL ACTION SUMMARY

This form has been prepared to support removal of the partially-buried produced-water vessel associated with this location. When this produced-water vessel was removed, soil samples were not collected. A hand auger boring will be completed to approximately 5 feet below ground surface (5' bgs) in the previous location of the vessel. Soil samples will be collected at each foot interval and field screened. At least one soil sample will be collected and submitted for laboratory analysis for TPH, BTEX, ph, EC and SAR based on the highest PID reading, or visual/olfactory evidence.

A hand auger boring will be completed to approximately 5 feet below ground surface (5' bgs) in the previous location of the vessel. Soil samples will be collected at each foot interval and field screened. At least one soil sample will be collected and submitted for laboratory analysis for TPH, BTEX, ph, EC and SAR based on the highest PID reading, or visual/olfactory evidence. If a release is discovered and confirmed through soil screening and/or laboratory analysis, and/or groundwater is encountered during removal activities, additional excavations may be conducted to further delineate horizontally and vertically. If the extent of impacts is reached and/or remaining impact analytical results are needed for future remediation activities, discrete soil samples will be collected from the sidewalls and base (if groundwater is not present) and analyzed for organic (TPH and BTEX) and inorganic (SAR, EC and pH) constituents.
