On 4/28/2020, a Form 17 was completed with a beginning pressure of 27 psi and it blew down to 0 psi. The well dribbled oil during the test on 4/28/2020 and for this reason Noble proposes to P&A this well by 10/15/2020. Mitigation efforts were not taken immediately after the the Form 17 bradenhead test conducted on 3/28/2019 and has since been disclosed to the COGCC through a self-report.
