## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Subsurface investigation took place on October 17th and November 21st, 2019. A Geoprobe direct push rig was used to advance 2 inch PVC sample liners to collect continuous core samples in 5 foot increments. A total of 7 samples were collected for analysis based on field screening results. Background samples were not obtained, as it's been previously established that the area has naturally occurring high levels of arsenic. Please see attachments for analysis and previously sampled arsenic levels.

### Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? ( Number, analyses, and locations of samples ):

A visual inspection was performed looking for signs of stained soil and potential leeching of pit components that may have impacted surface water or groundwater, none were found. Groundwater was not encountered during sampling.
