Comment:

This inspection conducted later in the growing season since the previous inspection has identified desirable vegetation establishment consisting predominately of Sand dropseed grass cover. This native warm season specie grows later in the season which was not observed in the spring time inspection. The vegetation appears to be uniformly established throughout the location however, the area was recently grazed by livestock. In comparison to the surrounding reference area the vegetation was determined to be at least 80% of reference area levels. The access road and location are recontoured and reclaimed. All equipment and debris have been removed. The location meets the final requirements.
