COMMENTS:

Noble has performed two blow downs on the State 16-0914 well. The first blow down, 5/27/2020, started at 119 psi and collected 69.6 mcf of gas and 0 gallons of liquid. The second blow down, on 7/9/2020, started at 125 psi and collected 72 mcf of gas and 0 gallons of liquid. On 5/24/2020, a production and bradenhead gas sample was collected and will be submitted once the lab analysis is complete. On 7/31/2020, a Form 17 was completed with a beginning pressure of 101 psi. Gas was present for the first 15 min and then blew down to 0. Due to the high pressure, Noble is electing to plug this well by 1/31/2021. Noble will continue to monitor and blow down in an effort to control pressure until the well is plugged
