Comment:

There has been significant precipitation events recently and overall the location appears to be stabilized. There is not much vegetation establishment at the reclaimed location and additional seeding may need to be performed in the fall season. The vegetation observed was mostly an annual cover crop. The beginning of the growing season was dry which may have impacted vegetation establishment. There are some areas of minor erosion and some of the erosion controls will need maintenance. Ongoing monitoring and maintenance will need to be performed.
