### **Description of Pre-Abandonment Notice:**

Approximately 78 feet of 6" steel pipe WRL-08-TLS-100-L2-1 from the LACT to the launcher (S end of the pipeline) will be removed. This segment of pipe is located entirely within the econode disturbance. The pipe will be replaced with 4" FlexSteel. The remainder of the piggable line will remain as is. A corrected geodatabase and layout map is provided showing the current route.
