## INITIAL ACTION SUMMARY

A contractor for Extraction was boring a new line under KPK's consolidation flowline (currently shut-in due to line being stung East of release) and an abandoned flowline, when they encountered a historical release via drill cuttings and tie-in access. There are no live lines in the area and the only active line was flushed before this release was discovered.

Final vertical and horizontal extent of the excavation will be based on results from collected grab soil samples. all soil Samples will be analyzed for TPH, DRO, GRO, ORO, BTEX, pH, EC, and SAR and verified complaint with COGCC Tale 910-1. At a minimum, one grab sample will be collected from each excavation wall as well as from the base of the excavation area.

If groundwater is encountered during excavation activities, one (1) grab sample will be collected and verified complaint with COGCC Table 910-1.
