Comment Wells appear to be waiting completion. Operator shall comply with Rule 1003 regarding the timing requirements to perform interim reclamation activities.

At the time of this inspection, undesirable and noxious weed management is required. It appears weed management efforts have been implemented this year with the evidence of mowed vegetation.

A List B Colorado noxious weed, Scotch thistle, was observed in both rosette and flowering growth stages along the northern fill slope. Seeds start to propagate two weeks after flowering. Operator shall use BMP's to properly control and manage both undesirable and noxious weeds.
