#### COMMENTS:

On 8/7/2020, a Form 17 was completed with a starting pressure of 168 psi and a ending pressure of 106 psi. Gas was present at start of test then changed to water. Gas present again at 15 min and then changed back to water. Gas & water samples were collected and will be submitted once the lab analysis is complete. Due to the high initial pressure and gas and water flow, Noble is proposing to plug this well by 2/7/2021. Noble will install automation, monitor and blow down as needed until the well has been plugged."
