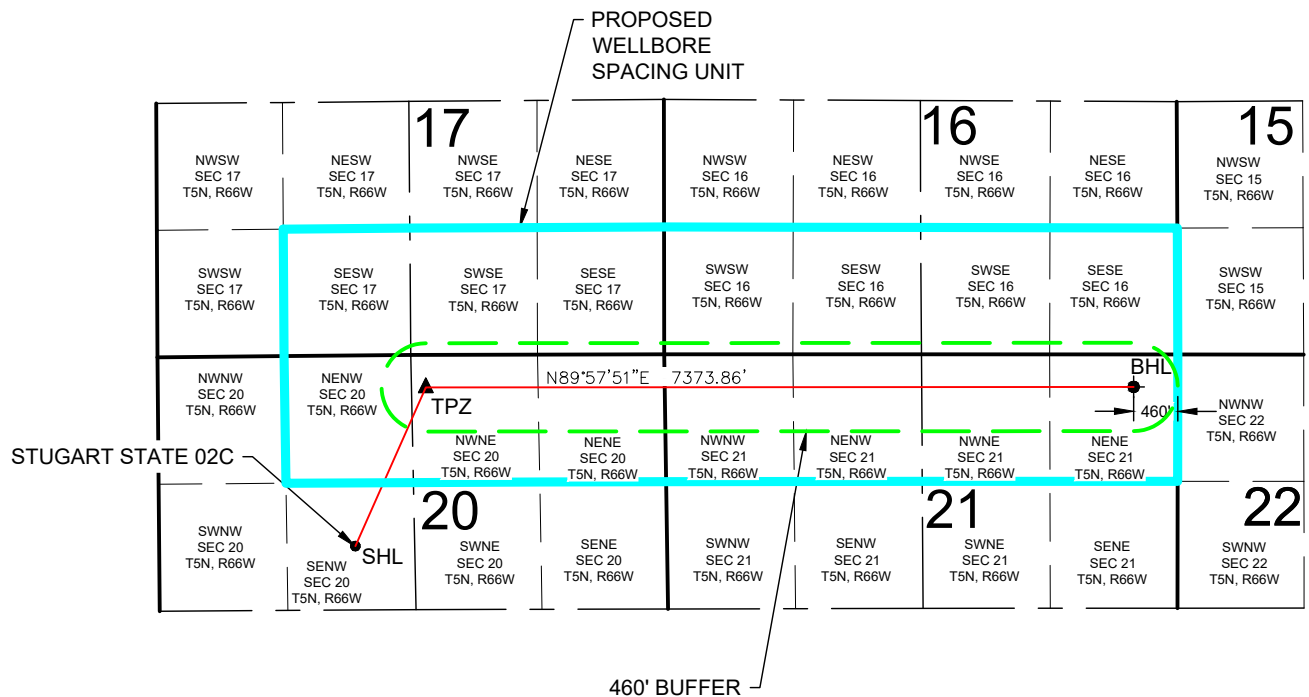

STUGART STATE 02C WELLBORE SPACING UNIT

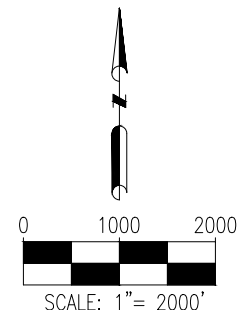


STUGART STATE 02C WELL TO BE LOCATED 1986' FNL AND 2044' FWL, SEC 20, T5N, R66W
