Comment:

The pipe riser remains at the location and is interfering with farming operations. All equipment should have been removed within three months of plugging the well. Previous corrective action has not been performed to remove the pipe riser. Previous inspection also documented that the crop had failed to establish in areas of the location. There was no crop growth during this inspection to evaluate crop establishment however, there are multiple areas of concern that are shown in the aerial image that need to be evaluated for crop establishment.

Unable to find evidence that additional reclamation has been conducted in accordance with rule 1004 and per corrective actions. Original corrective action and date remains applicable.

Corrective Action:

Comply with 1004 Rules.

Remove riser and perform additional reclamation activities in accordance to COGCC 1000 series rules and requirements. To allow Citation time to 1) determine issues on location hindering crop establishment/reclamation, 2) collaborate with the surface owner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production, and 3) collaborate with the midstream company to remove the riser remaining on the location, all reclamation activities shall be completed no later than 10/31/2018.
