 On 8-13-2020, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Maintenance issues with a production facility. The complainant Sandra Myer 90 County Road 55 Keensburg CO stated the issues were occurring on a well site, which is located on complainant's property.  
 On 8-13-2020, I attempted to make contact with the complainant who indicated the Opal facility appears to be abandoned she was concerned with separator building being in disrepair and no fencing around equipment that livestock and young children in area could be in danger.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did find several compliance issues with the KP Kauffman (Opal) facility. These issues are stated in my field inspection report Document # 693503280. At time of inspection well appeared to be shut in at wellhead.
