A cement bond log with gamma-ray will be run on the production casing (or intermediate casing if production liner is run). The horizontal portion of the wellbore will be logged with a measured-while-drilling log with gamma-ray. The Form 5, Completion Report, for this well will list all logs run and have those logs attached.
