Verify coverage with cement bond log. 3) Oil-based drilling fluid is to be used only after all aquifers are covered.

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5 for each well will state "Open Hole Logging Exception - No open-hole logs were run" and shall clearly identify the type of log and the well (by API#) in which open-hole logs were run.
