The 70 Ranch 10 West location (454560) was originally permitted with 13 wells. The two westernmost wells were drilled and completed as appraisal wells in 2018. The nine easternmost wells were developed in 2019 following the success of the appraisals. Two Form 2 wellbore permits, one for the subject well and one for 70 Ranch 10-21-3L, were left undrilled to provide space between the western appraisals and eastern development. There are no current plans to develop either well. As such, Confluence is presently abandoning the subject Form 2.
