Comment:

Operator has performed final reclamation activities, with the evidence of drill rows and straw crimped mulch. Germination was sparse throughout the access road and well location. Annual, weedy growth was observed throughout portions of the access road. Operator will likely need to perform ongoing weed management to suppress annual, weedy growth to allow for successful germination and establishment of perennial species. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards.
