COMMENTS:

TEP Rocky Mountain LLC (TEP) respectfully requests to temporarily abandon (TA) the Chevron GM 11-29 well for approximately 1 year. The well will be temporarily abandoned in order to drill and complete 14 additional wells on the existing Chevron GR 12-29 pad location (Loc ID #335260). The well will be returned to production once the proposed wells have been drilled and completed.

Two temporary bridge plugs were set downhole. One TSBP was set at 5154', and the other was set at 5124'. Both plugs were reported in Form 5A, Doc. #402471260. The old casing head was removed and replaced with a new weld on style "Time Saver" casing head and night cap. The Mechanical Integrity Test results were reported in Form 21, Doc #402457743.
