

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplete or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

Subject well was plugged and abandoned on 10/3/57, after drilling to a total depth of 9105', as follows:

- Placed 50 sack plug of slosset cement in the interval 8887'-9050' over the top of the Lyons. (Top of Lyons at 9030').
- Placed 50 sack plug of slosset cement in the interval 7552'-7715' over the top of the Muddy. (Top of Muddy at 7688').
- Placed 100 sack plug of common cement in the interval 372'-658' over 9 5/8" casing Shoe. (9 5/8" surface casing set at 523').
- Placed 25 sack plug of cement in top of surface casing with 4" marker embedded in same and extending 4' above ground level.

They were out of form 6's.
