Comment: There was no noxious weeds observed at the location. The previous year inspection observed Diffuse knapweed at the location. The weed control performed may have been effective but weeds may be dormant due to dry spring conditions. There are still areas of the location that have not adequately established vegetation. Additional growing seasons and seeding may be needed to adequately reestablish vegetation cover. Continue to monitor and manage this site until Final Reclamation has passed.
