TEP Rocky Mountain LLC (TEP) is requesting approval to install four (4) additional 500 bbl condensate tanks within the existing tank containment on the RWF 513-10 pad (COGCC Loc ID 335615), which is located in the NESW of Section 10, Township 6 South, Range 94 West, 6th P.M. Two (2) ECDs will also be installed along the access road southeast of the existing tank battery. The additional tanks and ECDs will be used to support development of the fourteen (14) proposed wells to be drilled on the proposed Federal RWF 43-9 Pad (Form 2A, Doc #402402151).
