COMMENTS:

During bradenhead testing after rig release this DUC well was found to have BH PSI of 314 PSI test dated 8/7/2020. The BH did not sustain continuous flow and a sample was collected, we are currently waiting on the results from isotopic analysis. We would like to blow the BH down for up to a 6 month period in hopes that it dissipates. After the blow down period we will conduct a buildup test and re-evaluate if further action is required.
