On September 19, 2019, four additional monitoring wells (BH21 - BH24) were installed cross- and down-gradient of the existing monitoring network to establish point of compliance. Quarterly groundwater sampling of benzene, toluene, ethylbenzene, and total xylenes (BTEX) will continue at the 24 site monitoring wells using USEPA Method 8260B. Groundwater monitoring will be conducted until four consecutive quarters of groundwater concentrations are in compliance with COGCC Table 910-1 standards are achieved.
