Comment: There are portions along the access road that were regraded and additional culverts are installed. There was rock check dams installed along the road however, the installation was not properly performed and additional check dams are needed. There was no outlet protection installed at the culverts. The slopes and disturbance areas will need to be seeded and stabilized. BMP's must be implemented in accordance with good engineering practice and must be maintained until final reclamation is achieved.
