<p>Comment: Sediment is discharging off of the southern project area, along the access road. Stormwater diversions are not adequately stabilized. Wattles at top of the cut-slope are out of alignment and largely do not appear to be functioning.</p> <p>Corrective Action: Long-term stormwater and erosion controls need to be installed to stabilize erosion and prevent sediment discharge from the project area. Stormwater velocities in diversions appear to be high and need to be reduced to prevent sediment loads being carried off site. Erosion controls need to be maintained on bare soils of the cut-slope until stabilized with desirable perennial vegetation. Sediment in roadside ditches and along the access road needs to be cleaned out. Stormwater and erosion controls need to be selected, sized, installed, and maintained according to good engineering practices such as those described by CDOT in their erosion control manuals.</p>						Date: 10/30/2020
