The proposed remediation schedule calls for soil amendment application during the month of November 2017 with attainment of EC, SAR & pH values less than Table 910-1 screening levels in 18 to 24 months verified by soil sample collection and laboratory analysis.

The areas will be re-seeded with a dryland pasture grass mix by hand broadcasting in the Spring of 2018. The location will continue to be included in Kinder Morgan's noxious weed prevention program.

**OPERATOR COMMENT**

Non-E&P waste (pit liner) was observed in three soil borings advanced at the MC-8 site. The drilling pit at the MC-8 location was closed prior to April 1, 2009 and, as documented in the Rule 523.e. Voluntary Self Disclosure Eleventh and Twelfth Quarterly Reports, the MC-8 site does not require a variance to Rule 905. A written agreement with the landowner to leave the pit liner in place is attached to this Form 27.

As stated in the Site Investigation Plan section of this Form 27, soil samples were collected from the same locations and depths (soil borings 3 & 6) of the former drilling pit where EC, SAR and pH concentrations in soil <3' below ground surface exceeded the Table 910-1 screening levels during site characterization soil sampling. The laboratory analytical report (attached) shows the current values for EC & SAR at soil boring 3 to be 1.030 mmhos/cm & 0.28 respectively, and the values for EC, SAR & pH at soil boring 6 to be 0.497 mmhos/cm, 0.18 & 7.68 respectively.

Regarding the former drilling pit at the MC-8 production well location, Kinder Morgan submits that the attached landowner agreement and analytical data from the re-sampling of soil borings 3 and 6 provide sufficient documentation to close Remediation Project #9886. Remediation photo log attached.
