Operator submitted FIRR #402463398 stating "weeds were sprayed" on 6/14/2020.</p> <p>It was observed in this inspection that initial weed management efforts appear to be insufficient; Musk thistle remains evident on access road and Location, with several plants observed to have reached seed head maturity and in the process of seed dispersal.</p>
