Remediation of TPH in subsurface soil will be accomplished by natural attenuation. Remediation of EC in soil less than 3' bgs in the areas surrounding B1, B3, B7 & B8 will be accomplished by surface application of a calcium soil amendment (gypsum). The proposed remediation schedule calls for soil amendment application during the month of November with attainment of EC concentrations less than Table 910-1 screening levels in 18 to 24 months verified by soil sample collection and laboratory analysis.

The YE-6 location is currently in interim reclamation status. The soil amendment application caused disturbance to the existing vegetation in the areas of soil borings B1, B3, B7 & B8. Those areas were re-seeded with a dryland pasture grass mix by hand broadcasting in the Spring of 2018. The location will continue to be included in Kinder Morgan's noxious weed prevention program.

**OPERATOR COMMENT**

Non-E&P waste (pit liner) was observed in three soil borings advanced at the YE-6 site. The drilling pit at the YE-6 location was closed prior to April 1, 2009 and, as documented in the Rule 523.e. Voluntary Self Disclosure Eleventh and Twelfth Quarterly Reports, the YE-6 site does not require a variance to Rule 905. A written agreement with the landowner to leave the pit liner in place is attached to this Form 27.

As stated in the Site Investigation Plan section of this Form 27, soil samples were collected from the same locations and depths (soil boring 1 at 0'-1', soil boring 3 at 1'-2', soil boring 7 at 2'-3', soil boring 8 at 2'-3', and soil boring 2 at 11'-12') of the former drilling pit where the EC value in soil <3' below ground surface and TPH concentration exceeded the Table 910-1 screening levels during site characterization soil sampling. The laboratory analytical reports (attached) show the current value for EC at soil boring 1 to be 1.940 mmhos/cm, EC at soil boring 3 to be 1.990 mmhos/cm, EC at soil boring 7 to be 0.642 mmhos/cm, and EC at soil boring 8 to be 1.020 mmhos/cm, and the concentration for TPH at soil boring 2 to be 59.8 mg/kg, all of which are less than the Table 910-1 screening levels.

Regarding the former drilling pit at the YE-6 production well location, Kinder Morgan submits that the attached landowner agreement and analytical data from the re-sampling of soil borings 1, 2, 3, 7, and 8 provide sufficient documentation to close Remediation Project #9858.
