Due to lack of available field screening tools, Caerus was unable to determine the approximate area where inorganic concentrations met COGCC Table 910-1 Concentration Levels during drilling activities. Therefore the site was drilled to a pre-determined depth of 50 feet below pad surface which was approved via COGCC Document 402297038.
