The Cornish 22-10 Well and access road disturbances have been final reclaimed and revegetated. The well was serviced by a centralized battery (40.505103/-104.428802) that is currently in the maintenance and monitoring stages of reclamation. The battery is associated with two additional locations (Location IDs 306299 and 306301) and closure will be pursued with them. Please see the attached report for additional reclamation activities, details on the completed vegetation assessment, and photo documentation of the Cornish 22-10 location.
