Plugging procedure as per telephone conversation with Jim Kinney and Dave Reid (Bright & Co) on 5/21/93:

- Set cement plug #1 from 6073' to 5850' with 50 sx Prem. Cmt. + .1% HR-5 (15.8 ppg + 1.15 cu ft/sk). Plug in place at 11:30 AM, 5/22/93.
NOTE: 7-5/8", 26.4# casing set at 5986'. Hole size below 7-5/8" casing = 6-1/2"
- Cut 7-5/8", 26.4# casing at 3350'. Pulled and layed down casing.
- Set cement plug #2 from 1463' with 50 sx.
- Set cement plug #3 from 1245' with 50 sx.
- Set cement plug #4 from 498' with 50 sx.
NOTE: 10-3/4", 32.75# casing set at 434'.
- Set cement plug #5 from 30' with 35 sx.
- Cut-off 10-3/4" casing 4' below ground level and weld on metal plate.
- Set 7.5 sx cement plug in rathole. Set 7.5 sx cement plug in mousehole.
