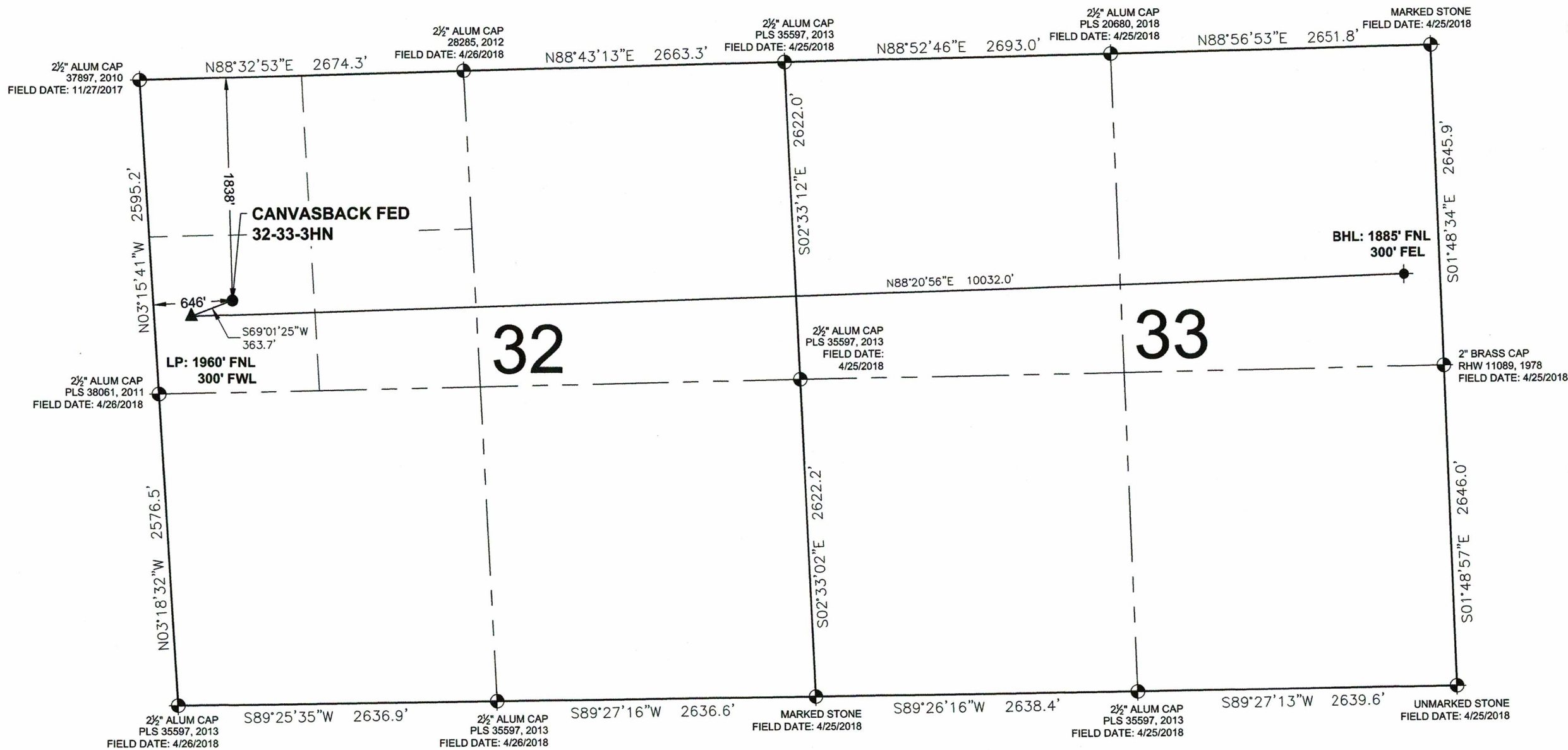


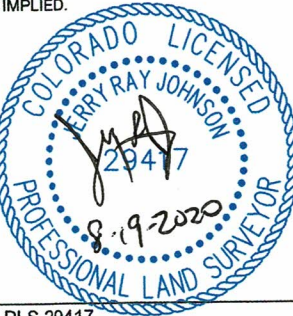
CANVASBACK FED 32-33-3HN

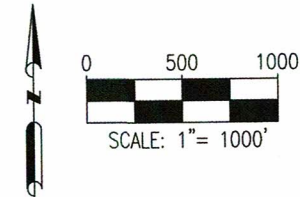
