This sundry is part of a realignment to maximize efficiency of wells under approved Order 535-1154 covering Sections 2 & 11 of 8N-60W.

WOGLA18-0143 was submitted 10/1/2018, approved 11/6/2018.

The PT-1 (API: 05-123-46553) to be known as Pintail Fed 3-15-9HN is being renamed and adjusted to extend into Sections 3, 10, and 15 with revised TPZ and BHL to meet setbacks in accordance with proposed spacing amendments within approved Order 535-1325. The SHL will move within the Pintail Pad (Loc ID 454414) for engineering purposes.

The PT-2HN (API: 05-123-46550), PT-3HN (API: 05-123-46552), PT-4HN (API: 05-123-46551), PT-5HC (API: 05-123-46541), PT-6HC (API: 05-123-46548), and PT-7HN (API: 05-123-46549) are being abandoned from this location.

The Pintail Fed 2-11-4HN (API: 05-123-46547), Pintail Fed 2-11-5HN (API: 05-123-46555), Pintail Fed 2-11-6HN (API: 05-123-46545), and Pintail Fed 2-11-7HN - also changing from Codell to Niobrara - (API: 05-123-46543) are being respaced across Sections 2 and 11 with revised TPZ, and BHL.

Sundry Doc #402449282 is being submitted for the Pintail Pad location to update the multi-well plan.

There have been no new buildings constructed and no changes to the surrounding land use and mineral lease description. The well site began construction 8/24/2020. This location is not in a buffer or exception zone, so no notices are required under Rule 305. All previously submitted notices, Surface Use Agreements, and letters are also still valid.
