

DETAILS OF WORK

Confirming: Strider to Frazier 10-9-58.

Gulf Designation: Ballinger-Federal No. 2a.

Well No. 2 was drilled to a total depth of 2072'. The 8-5/8" OD surface casing was cemented at 324' with 175 sacks, did not circulate, re-cemented from surface with 50 sacks, circulated. Casing parted at 104' and 166'. Top 3 joints and bottom 5 joints O.K. Unable to wash over or fish loose joints. Recovered top 3 joints. Cemented top 100' of hole with 150 sacks cement. Will skid rig 12' and drill new hole #2a. Will use 10-3/4" OD surface casing on new hole. Will set approximately 350' of 10-3/4" OD and cement same to surface.
