	Operator will run a CBL and submit along with details of the liner and cement on a Form 5. If cement is not drilled out to previous completion, report cement plug on a Form 5A. The plug would render the well Temporarily Abandoned and require a satisfactory MIT, followed by a Form 21. The 5, 5A and MIT are required within 30 days of the repair and the Form 21 is due 30 days after the MIT. Operator indicated that there is a CICR in the well at 4797' with a squeeze below to shut off water influx which should be included on the subsequent 5 as the plugback depth prior to running the liner.
