**General Comment:**

On 9/23/2020 Catherine Roy conducted a reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

-Control weeds. Corrective action is back-dated to document original corrective action date- 8/2/2019.

Corrective action from 2019 reclamation inspection to control weeds is partially addressed as musk thistles appear to be controlled on the access road. Goatgrass was not observed, but viable seed may still be present due to early spring flower timing of the species. Russian knapweed remains.
