COMMENTS:

Tied in 8/31/2020 and started up 9/8/2020. The surface casing was tied into the production flowline to keep the bradenhead pressure below 50 psi. A form 17 test was performed on 8/03/20, to prior to tie-in. A surface casing sample was taken. Crestone will leave the surface casing open to ensure the pressure remains down. Crestone will monitor the pressure and continue with annual testing.

An annual bradenhead test will be conducted within 30 days of 08/03/2021 to reflect 12 months the proposed mitigation. A form 17 will be submitted within 10 days of the bradenhead test. A subsequent Form 4 sundry will be submitted within 60 days of the bradenhead test date that will address future plans (including mitigation, as needed). The Form 4 sundry may request the extension of or supersede the former mitigation plan described in this sundry.
